### **Photographs supplied by applicants**

We will use photographs supplied in Applications only internally and privately for the purposes of handling Applications, to the exclusion of any other use. We shall handle such photographs in accordance with our privacy policy.

If you supply a photograph in an Application (**Photograph**), you hereby grant to us a non-exclusive, royalty-free licence to use, store and copy the Photograph during the application process.

You warrant that:

- a) you are the copyright owner of the Photograph or are authorised by the copyright owner of the Photograph to enter into the above licence.
